### THEY SAY...

**You and the Catholic Church are just bigoted.**

**My marriage doesn't affect your marriage, so what do you care?**

### WE SAY...

**Marriage is more. It is about ensuring the well-being of children and society.**

If marriage is just a committed relationship for the benefit of adults, then there is no reason for the government to get involved. But marriage has an important public component. It ensures the well-being of children and society. Social trends continuously show that children deprived of married mothers and fathers don't fare as well economically or emotionally as children with a married mother and father.\*

**Do you really think that people who think that both mothers and fathers matter to kids are bigoted?**

Marriage is about uniting kids with both moms and dads. Two men or two women cannot produce a child. It's not bigotry to think this because it's not discrimination to treat different things differently.

**How marriage is defined will not only affect how children view the importance of mothers and fathers in the future but also our community's religious freedoms right now—I care about that.**

I'm not ready to say to any child, "Hey, it doesn't matter that you don't have a dad. You don't need him anyway." And really, that's what I would be saying if I supported redefining marriage.

Those who share my beliefs are already facing lawsuits and penalties for following their consciences.\*\* Their rights matter too.
